Course summary

The aim: to develop a competences to evaluate contemporary business integration drivers, motives, and impacts from the perspective of value chains.

Objectives:

- By providing state-of-art theories, methods, and topics to deepen knowledge about value chain integration processes
- To develop critical thinking to evaluate *pros* and *cons* of value chain approach
- To understand the role of Industry 4.0, and the role of intellectual property rights development in value chain formation processes
- To understand the role of clasterization
- To understand organisational and structural aspects of business integration processes (merges and acquisitions, alliances, remote management structures)
- To be able to evaluate and to analyse the role of R&D in value chain formation processes

Short description

Business Integration course focuses on state-of-art research of value chain design and management in the context of global business integration. This course explores the ways companies overcome challenges when operating in EU market or globally, a process unique for its complexity and uncertainty. Therefore, companies striving to succeed in the global economy need to develop specific strategies and value chain management models

Course content

Value chain. Challenges of business integration. Motives and drives of value chains creation. The impact of ideas, partnerships and competences on business integration. The role of science-business and R&D collaboration in value chain creation. Business integration processes and competitive advantage. Business integration support from the perspective of EU business-innovation networking. MNEs and global production and business networks. Strategic business partnerships. Merges and acquisitions, strategic alliances, clusters. The impact of Industry 4.0 revolution and intellectual property on value chain development.
