- English proficiency: at least B2 level (e. g. IELTS 6.5+ / TOEFL iBT 81+), demonstrated by any recognized certificate and assessed in the motivation interview
- Online motivation interview
- N. B. for non-EU/EFTA applicants: The gap since your completed secondary degree should not exceed 5 years
