Entry requirements for Lithuanian students

- University BA degree in Economics or Business and Public Management
- University BA degree in other fields +20 ECTS from the management (compulsory) and marketing, economics as well as business or public administration fields
- University BA degree in other fields and 3+ years of professional work experience in the field of the study programme
- Completed university studies in other fields or professional bachelor studies and complementary studies at VU FEBA



Entry requirements for foreign students

- BA degree or equivalent
- 20+ ECTS credits in the fields of Economics, Management, Marketing and other similar fields, or 3+ years of professional experience in the field
- English language proficiency at a level not lower than B2
- Motivational interview
- General admission requirements
- N. B. for non-EU/EFTA applicants: The gap since your completed Bachelor degree should not exceed 5 years
